TERMS AND CONDITIONS FOR USE OF THE IOMEID.COM WEBSITE AND THE ASSOCIATED SCOTEID.COM DATABASE provided by ScotEID.com Limited, a company limited by guarantee and registered in Scotland, having company number SC382963 and having its registered office at Rural Centre, Ingliston, Edinburgh, EH28 8MZ (hereinafter called "ScotEID")

# INTRODUCTION

These terms and conditions apply to (i) the entire contents of the website under the domain name IOMEID.com ("Website"); (ii) the relevant contents of the ScotEID database which is to be found on the Website whether in electronic or hard copy form or otherwise ("Database"); and (iii) any correspondence between ScotEID and you or your employees or agents. Please read these terms and conditions carefully before using the Website and/ or the Database. Using the Website and/ or the Database indicates that you accept these terms regardless of whether or not you choose to register with the Website. If you do not accept these terms, do not use the Website or the Database.

ScotEID may revise these terms and conditions with any reasonable updates at any time by updating this posting. You should check the Website from time to time to review the then current terms and conditions, and are intended and accepted as binding on you.

## 1. DEFINITIONS AND INTERPRETATION

- 1.1 In these terms and conditions the following definitions shall apply unless the context requires otherwise:-
- "CCP" means the meat plant or livestock market on the Isle of Man (Critical Control Point) and any other CCP on the isle of Man approved by DEFA;
- "DEFA" means the Isle of Man Government Department of Environment Food and Agriculture; "Sheep Order" means The Sheep and Goats (Records, Identification and Movement) Order 2015 [Isle of Man];
- "writing" includes facsimile transmission, e-mail or comparable means of communication;
- "you" means the person or organisation (and its employees and officers) registered with ScotEID or accessing the Website, and includes any agent engaged by that person or organisation and "your" shall be interpreted accordingly.
- 1.2 Any reference in these terms and conditions to any statute or provision of a statute shall be construed as a reference to that statute or provision as amended, re-enacted or extended at the relevant time.
- 1.3 The headings in these terms and conditions are for convenience only and shall not affect their interpretation.
- 1.4 Unless the context otherwise requires, references in these terms and conditions to "person" includes any individual, company, corporation, firm, partnership, joint venture, association, organisation, institution, trust or agency, whether or not having a separate legal personality.
- 1.5. The rights and protections of ScotEID under these terms and conditions may be exercised and claimed by Scottish Agricultural Organisation Society Limited ("SAOS"), which is primarily responsible for managing and continuing research in connection with the traceability of farm livestock in Scotland.

## 2. REGISTRATION

- 2.1 You may access some areas of the Website without registering your details on the Website.
- 2.2 You can register your details on the Website by completing the registration form ("Registration") at https://www.iomeid.com. You may gain assistance with registration by

telephone to the ScotEID information centre on 01466 794323. Each registration is for a single user only. ScotEID does not permit you to share your user name and password with any person nor with multiple users on a network.

- 2.3 You undertake that all the details you provide to ScotEID on the Registration are true, complete and accurate.
- 2.4 By submitting your Registration you are responsible for maintaining the confidentiality of your password for the Website. Please inform ScotEID immediately if your password is disclosed to a third party. ScotEID shall have no liability for any activities that occur on your account or for any data that is either inputted, inputted incorrectly or is failed to be inputted by you or any third party, including ScotEID on the instruction of you, your employees or your agents, (on your behalf or otherwise) in any circumstances.
- 2.5 You acknowledge that the Website and the Database will be used for continuing research for the identification and traceability of livestock in the Isle of Man and potentially in Scotland, to improve production efficiency and reduce disease incidence. As such, you agree to reports being produced for any DEFA regulatory body and consumer representative organisations from time to time for this purpose and agree to provide ScotEID with such information as it may reasonably require from time to time in relation to this subject matter.
- 2.6 By submitting your Registration you agree to give feedback to ScotEID on the Website and/ or Database on ScotEID's reasonable request.
- 2.7 By submitting your Registration you accept that you may be contacted by ScotEID for research purposes.
- 2.8 You agree that other persons registered with ScotEID may view data relating to the livestock kept by you.
- 2.9 For the avoidance of doubt, paragraphs 2.5 and 2.8 shall apply to you irrespective of whether you have registered with ScotEID on the Website.

### 3. REGISTRATION BY KEEPERS OF SHEEP AND GOATS

The provisions of this clause 3 shall only apply to keepers of sheep and goats. You:

- 3.1 acknowledge that in order for ScotEID to sample and verify information, access to your farm holdings may exceptionally be required with your consent;
- 3.2 agree to co-operate and assist at CCPs and, if necessary, to resubmit your sheep for electronic reading if any of the equipment at such CCPs fails or the accuracy of their readings would benefit from re-testing;
- 3.3 Confirm that you own or keep sheep such number of which are notified on the Registration;
- 3.4 shall be responsible for and agree to comply with any legislation or regulations governing your keeping of sheep including the Sheep Order;
- 3.5. acknowledge that the accuracy of the information contained on the Database must be checked by You. Neither ScotEID nor the CCP shall have any responsibility in respect thereof; 3.6 agree to regularly maintain all the movements and other appropriate records of your flock on the Database on the Website and that all the information submitted to the Website shall be true and accurate. If it comes to your attention that the Website has been provided with erroneous reports you agree to notify ScotEID of the error as soon as reasonably practicable; 3.7 Registration by Keepers who also keep cattle or pigs on the area covered by the sheep fock or goat herd must confirm that you keep pigs and cattle as notified on the registration.

### 4. PROVISION OF WEBSITE AND DATABASE

- 4.1 The Website and Database is continually innovating and ScotEID will try to update the Website and Database based on feedback received. You acknowledge and agree that the form and nature of the Website and Database relating thereto which ScotEID provides may change from time to time without prior notice. You also acknowledge and agree that ScotEID may temporarily stop providing use of some or all of the Website and/ or the Database without prior notice.
- 4.2 You agree not to misuse the Website and/ or the Database (including, without limitation, by hacking).

- 4.4 ScotEID does not endorse, accredit or regulate any providers of farm management software and/ or software used by any CCP and any use you make of such providers or software in conjunction with the Database is entirely at your own risk.

#### 5. DATA

- 5.1 You acknowledge and agree that neither ScotEID nor a CCP gives any representation or warranty (whether express or implied) as to the accuracy or completeness of the data contained within the Database or Website. Whilst ScotEID may from time to time alert you to a potential inaccuracy in the Database in respect of your data, you acknowledge that it is not ScotEID's responsibility to do so.
- 5.2 If it comes to your attention that the Database contains inaccurate information relating to your livestock, you agree to notify ScotEID of the error as soon as reasonably practicable and to thereafter satisfy yourself that the Database has been promptly corrected.
- 5.3 You retain copyright and any other rights you already hold in any information you submit through the Website. However, you hereby grant to ScotEID and its other Database users a perpetual, irrevocable, worldwide, non-exclusive and royalty free licence to reproduce, process, modify, adapt and publish the same on any format. You waive any moral rights therein and any other rights to be acknowledged as the author.
- 5.4 You accept that you shall not obtain any intellectual property rights in relation to any of the information or data contained on the Website (save in relation to any information or data submitted by you).
- 5.5 You accept that ScotEID or its agents may obtain and process personal data of you or your employees (personal data is defined by the Data Protection Act 1998 ("DPA")) and consent to such processing. As part of ensuring that any such personal data is processed fairly ScotEID is obliged by the DPA to provide you with the following information:

- 5.5.3 CPH numbers (CPH numbers contain sheep flock or goat herd number) and Animal ID's will be used by ScotEID only for the purposes of administering the Website and/ or the Database (including any developments thereto), and reporting to any organisations which in ScotEID's opinion is reasonably necessary for the furtherance of research, review and analysis

- of livestock identification and traceability in Scotland and the Isle of Man, to improve production efficiency and reduce disease incidence.
- 5.6 You hereby consent to the release of your data on the Database to such organisations as aforesaid and DEFA. It is accepted that such report may be made public. Your data will not be disclosed by ScotEID to any organisation for any other purpose other than in relation to cases of suspected fraud.
- 5.7 You accept that County Parish Holding numbers and animal ID's do not constitute "personal data" as defined in the DPA.
- 5.8 You are prohibited from posting or transmitting to or from the Website and/ or the Database any material:
- 5.8.1 that is threatening, defamatory, obscene, indecent, seditious, offensive, pornographic, abusive, liable to incite racial hatred, discriminatory, menacing, scandalous, inflammatory, blasphemous, in breach of confidence, in breach of privacy or which may cause annoyance or inconvenience; or
- 5.8.2 for which you have not obtained all necessary licences and/ or approvals; or
- 5.8.3 which constitutes or encourages conduct that would be considered a criminal offence, give rise to a civil liability, or otherwise be contrary to the law of or infringe the rights of any third party, in any country of the world; or

- 9.3 You shall keep confidential and not disclose and shall procure that your employees and agents keep confidential and do not disclose any information of a confidential nature obtained by reason of any contact between you or them and ScotEID including your use of the Website and/ or the Database except information which is in the public domain otherwise than by reason of a breach of this provision.
